- This appeal is filed challenging the order dated 22.06.2023 in 2. Bail Application No.863 of 2023 passed by the High Court of Judicature at Bombay, Bench at Aurangabad. The Appellant was arrested on 27.03.2023 in connection with Crime No.169 of 2023 registered with Karjat Police Station, District Ahmednagar, Maharashtra for the offences punishale under Sections 307, 326, 324, 323, 341, 143, 147, 148, 149, 506, 109, 114, 329 of the Indian Penal Code, 1860 (I.P.C.). The High Court *vide* impugned order allowed the Bail Application of the appellant, however, with a condition to deposit ₹1,00,000/- with the Trial Court compensation to the victim. The appellant is aggrieved by the said condition and hence, preferred the captioned Criminal Appeal.
- 3. Heard the learned counsel on both the sides.
- 4. On 21.07.2023, this Court had passed an order staying the aforesaid direction to deposit the amount of ₹1,00,000/- with the Trial Court as compensation to the victim. This Court, time and again, deprecated the practice of putting such conditions while granting bail.
- 5. In that view of the matter, the order of this Court dated 21.07.2023 is made absolute and the instant Criminal Appeal stands disposed of by setting aside the condition for deposit of ₹1,00,000/-.
